- a) Norwich Public Utilities: Extend public water main to span Trading Cove Brook on Noble Hill Road

D. Hayward presented a site plan to the commission and discussed the location of the 24 inch water main as it would span the Trading Cove Brook on Noble Hill Road. A steel structure mounted on concrete footings would support the water main above ground with no adverse impact to the wetlands. The disturbance of soil would be limited to the immediate area of the new footings and straw hay bails would be put in place to minimize sediment from entering the wetlands during construction.

C. Mandel asked if NDDB was contacted and if they had submitted a report listing any protected species in the area.

R. Russo responded NDDB will be submitting a report which will be available for the commissioners to review.

C. Mandel stated an ENS Bond would be required and the as-builts filed in the town hall once the project is completed.

C. Mandel requested the NDDB report provided to the commissioners for review before the next meeting and the area where the footing will be placed delineated for the commissioners to view during a site walk.

S. Taylor made a motion to table action on the issue until the next meeting.

S. Brunetti seconded the motion.
