FIRST SELECTMAN'S CORNER

The work at the Transfer Station is progressing smoothly and it is hoped to be fully back in operation before the projected September 30th date originally reported. Thank you all for your patience and cooperation in utilizing the temporary site at Sterling Superior Services on Commerce Park Road.

A meeting of the area Town Chief Executive Officers was held at Southeastern Council of Governments on Wednesday regarding masking and other protective measures. The Governors Executive Order ability will expire on September 30th, as such, municipalities will still have the ability to enact precautionary measures beyond that time. For the time being, Bozrah will allow personal choice, except for the Town Hall and the mandated masking at Fields Memorial School. This will be closely monitored via infection reports from Uncas Health District. Vaccination is still highly recommended.

Two bids for the underground fuel tank replacement at Fields Memorial School were opened on Wednesday, August 25th with proposals being nearly double. The Board of Education and Construction Designers are working to resubmit the revised numbers for State Grant and local funding. The replacement is mandatory due to the age of the tank.

The recent announcement of the need for a Water Pollution Control Authority member was made in error. The replacement is Selectman Jeremy Tarasevich who will replace First Selectman Carl Zorn.

The inordinate rainfall Wednesday into Thursday resulted in many washout issues around town. DPW and Emergency Management personnel from our Town responded to quickly address affected areas and to clear debris and restore hazards that were created.
