G. Pianka reported during the Christmas Holiday a compliance date expired so he requested an extension and sent in the documentation. A work place study on noise generation is necessary, G. Pianka met with Billy Eyeburse to create a noise plan. \$1920 was spent on fines.

Item 11: <u>BLPCo Micro-Grid Proposal</u> – Discussion/ action plan

G. Pianka met with Randall Supernaut who was looking for him to sign papers, on behalf of the Town, endorsing support for federal grant money. G. Pianka felt this should be brought to the board for discussion. R. Supernaut and Gage Stern presented the board with the plans of the grant, he feels it will be good for the town and all finances will be covered with the grant. The grant is for up to \$3 million. This will not cost the town anything, just looking for endorsement from the town. This will be further discussed at the Town Utility Commission meeting on January 25, 2017.

Item 12: <u>State of the Town – Presentation:</u> Discussion/ budget pre-plan and suggestions

G. Pianka discussed items for budgetary consideration. He noted on the Ice Rink at River Walk, Fields Memorial Soccer Field development, Fitchville Road maple placement, the sidewalk development project on Fitchville Road, the intersection of Wawecus Road and Salem Turnpike, Rte. 82 city water line installation, and the wall across from Air Gas on Stockhouse Road, and the sewer construction project.

He also discussed with Maples Farm Park Commission to create a 5 year maintenance plan. He wants to create a 3 year plan for the purchase of a full size DPW plow truck, a plan to replace the mill fencing, improvements at the DPW town garage facility, the town hall computers are in need of updated programming, have OSHA compliance records at all town sites and open land funding.
