TOWN EMPLOYEE POLICY: NON-INSURANCE COVERAGE

The Town of Bozrah offers comprehensive medical/health, dental and vision insurance coverage for its' employees. The Town of Bozrah offers access to this benefit upon employment. The rate of contribution by the employee is 10% of the actual cost of the policy coverage selected.

Occasionally that employee has access to such coverage through other domestic partnerships. Should the employee opt-out of this benefit they are entitled to receive what would have been their 10% contribution as compensation. This payment will be calculated and paid at the end of each fiscal year (June 30th) unless that employee terminates employment, in which case the amount earned will be prorated.

A declaration of which coverage: Employee, Employee Plus Dependent or Employee Plus Family must be declared with the Accounting Administrator. Earned compensation for this benefit will be reported annually to IRS via W-2 or 1099 as recommended by Standardized Accounting Practice

TOWN BUDGET POLICY: AWARDS AND SCHOLARSHIPS

The Town of Bozrah Fiscal Year budgets provide operating funding to promote the various missions of the Boards and Commissions. Recent question as to the appropriateness of budgeted funding usage for Awards and Scholarships has prompted clarification of authorized expenditure, as follows:

- 1) For continuing education of Board and Commission members
- 2) For plaques, trophies and paper certificates for Board and Commission members, and in the case of the Recreation Commission: for duly registered participants of any sport or activity sanctioned by the Recreation Commission
- 3) In no case will monetary (cash, check or otherwise) awards or recognition be issued from the use of Town of Bozrah Fiscal Year budgetary appropriations.
- 4) The various Boards and Commissions are not prohibited from sourcing Award or Scholarship funding. The Board of Selectmen are specifically prohibited from actively seeking contribution to any such fund-raising effort. Funds raised for the purpose of Awards and/or Scholarships will be properly recorded in the minutes of the involved Board or Commission and deposited into the Student Activity Fund at Fields Memorial School, with disbursements similarly recorded, per auditing requirement.

Gentlemen,

The radio frequency that many area fire departments mainly operate on, LOW BAND, is being phased out and it is becoming very hard to find equipment on this band if existing equipment fails (many manufacturers has stopped producing low band equipment). There has been a push to move emergency services to the 800Mhz band, which is a statewide system that has been built out by the State of Connecticut. Because it can become costly to outfit complete departments with this equipment as well as area dispatch centers this has been a slow transition. As of late though, due to the availability of American Rescue Funding, many area town and our mutual aid partners are utilizing these fund to transition to the 800Mhz band.

As you may have seen in a recent newspaper articles, Norwich is transitioning their system to the 800Mhz band, which will include all six fire departments. Willimantic Dispatch Center is receiving funds which will transition the five departments they dispatch which includes Franklin and Lebanon is also working on a plan for the switch as well. Our dispatch center is in the process of adding the the ability to transmit and receive on this frequency and there are about 1/2 a dozen departments dispatched through QV actively working on plans to transition that I am aware of and there may be more.

After discussing this with Chief Sholes, we are in agreement that this would be a proactive project to maintain interoperability with our surrounding mutual aid departments. Eventually, we will be forced to upgrade our equipment and as with anything, the longer it is prolonged the more costly it will become. I am asking for your consideration, if funding is available, that monies in the second allocation of ARF funding be utilized for this upgrade. I have contacted our radio vendor, and because this is a statewide system, we need to begin the process with the State of Connecticut to gain permission to access this system. Once granted, the vendor can produce a formal quote which they currently cannot do with out state permission. Chief Sholes also stated that he would withdraw his request for turnout gear funding to put it towards this project if approved. A **preliminary cost estimate I** was able to obtain from our radio vendor would put this project in the area of \$50,000.00. If you think this is a feasible project I will continue to get more hard numbers once approved by the state as this is lengthy approval process.

No more 'Band-Aids' and 'bubblegum.' Norwich dispatch radios to see muchneeded upgrades.

With \$3.4 million in federal funding provided through the American Rescue Plan, Norwich City Council gave the green light for a series of substantial upgrades to the city's antiquated emergency dispatch system.

"We have known for a decade, maybe longer, that our dispatch center was in serious need of an upgrade," said the council's president pro-tempore, Joseph DeLucia.

Some improvement came in 2018 when Norwich voters approved a ballot question to upgrade radio systems used by the police department.

Completed earlier this year, the work almost entirely eliminated so-called "dead areas" in the city where officers responding to a call could not communicate clearly with dispatchers.

Now, with the benefit of the federal funding, council members approved upgrades to replace antiquated equipment and improve communications for the city's six fire departments.

"The main problem is they are operating on two separate bands, so it makes it difficult for the individual departments to talk to each other – they are carrying multiple radios and switch back and forth to frequencies, and at fires that is a danger," DeLucia explained.

As it stands now, volunteer departments in Norwich operate on a "low band" frequency while the Norwich Fire Department uses "high band" radios, requiring firefighters to monitor communications on two separate radios in order to communicate with each other.

A third, Ultra High Frequency, UHF, radio is used to communicate with departments in other towns when responding to mutual aid calls, explained Taftville Fire Chief Timothy Jencks.

"What we did is we actually put a specific low band, high band, and UHF radio – three radio heads, one for each different frequency in the cab of the truck so when you are responding you are able to know what is going on," Jencks said.

Beyond having to juggle multiple radios when communicating between departments, the outdated low band radio technology creates other problems.

"I joke around about it, it's got Band-Aids on top of Band-Aids, unfortunately," said East Great Plains Fire Chief Keith Milton of the aging radio infrastructure. "The worst part is it's getting tougher and tougher to find parts for repairs for equipment that breaks down or even purchasing new stuff because companies are just getting away from it."

The poor technology combined with the city's topography also results in parts of the city where communications between volunteer fire departments and the city's dispatch center, located at the Norwich police station, are "very, very poor," Milton added.

"I will be talking on my portable radio talking to the dispatcher and talking to one of my trucks that is responding to give them some information and they might not hear anything that I am saying. And even the dispatch will say 'hey can you repeat that, you are very broken up," he said.

DeLucia underscored the need to address the technology used by the fire departments.

"You just cannot have communications fail when you are asking people to crawl into a building to fight a fire and rescue people," he said. "Volunteered or paid, they are running into danger when other people are running away — they need to have radios that work, it's that simple," the city council member said.

Another key component of the planned upgrade will see the installation of computerized dispatch consoles at the Norwich Police Department, replacing ones currently used that DeLucia described as "cumbersome" and "held together with Band-Aids and baling wire and bubble gum."

Dispatchers working at the police station are responsible for calls for police, fire, and emergency medical services and sometimes must use different computers to complete basic tasks.

"Right now, if I say give me my second alarm for a street, [the dispatchers] have to go to another computer to look up a PDF file to find out what they are supposed to send," Jencks said. "Our dispatch program is just antiquated, so this will modernize and streamline it so that everything will be at their fingertips."

Staffing levels also need to be addressed

The new technology for the dispatch center is welcome, Jencks said, but to get the most out of the upgrades will also require city leaders to address inadequate staffing levels.

"We have had fires where there has been one dispatcher on," the Taftville Chief noted.

DeLucia echoed the concern, explaining the problem is largely a result, "of budgetary constraints."

"If we are using [American Rescue Plan] money to fix part one — the [low band frequency] and the physical assets," he said. "We are going to have to find a way in our budget process to staff it adequately so that we have all this equipment and get the people trained to run it," he said.
